**On the Cover:** Schematic of the various cholesterol lipoprotein elements in the blood. Non-HDL-cholesterol (Non-HDL-C) measures cholesterol in all atherogenic lipoproteins. Each of these protein molecules contains one molecule of apolipoprotein B (Apo B). Thus, non-HDL-C and/or apoB predict risk similarly or better than LDL-C.
